The uploaded photo will be having a validity of ten years from the date of photograph taken.

In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50



years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications:

1. Pass in SSLC (Graduates are not eligible)
2. Knowledge of cycling
3. Must possess good Physique.

Note : 1. Rule 10 (a) ii of KS & SSR Part II is applicable to this post.

2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

8.Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be the one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. The profile correction made by the candidate in the office of the kerala Public Service Commission on request after last date fixed or receipt of application will not be reflected in the application. Such corrections will be in effect on the date on which corrections have been made. **Candidates who have AADHAR card should add, AADHAAR card as ID proof in their profile.**
